Petitioner, Gerald M. Hing, as trustee the Oh Thiam Hock/ Helen Hing Oh Scholarship Trust Fund B (hereafter the "Trust") having filed his First Account and Report of Trustee and the same having come regularly on for hearing, the Court finds that:

1. Due and legal notice of the hearing of the Petition has been given for the period and in the manner required by law.

2. The Trust was created under the will of Helen Hing Oh (hereafter the "Decedent") and funded with \$1,000,000.00 Singaporean, where the decedent resided at death and where the estate was administered. By order of this Court, Petitioner was confirmed as the sole trustee of the Trust on March 5, 2003. After repeated requests by Petitioner for release of the Trust funds, co-executors of the Decedent's estate in Singapore finally released the Trust funds to Petitioner via wire transfer on or around August 4, 2003. By order of this Court, on October 14, 2004 the

1 provision of statutory notice via website was approved.

2 3. Petitioner filed his First Account and Report of Trustee for the period of August 4,
3 2003 through August 31, 2005.

4 4. Petitioner intends to file annual trust accountings going forward.

5 5. Petitioner intends to develop appropriate eligibility criteria and distribution
6 guidelines for approval and ratification by this Court.

7 NOW THEREFORE, it is hereby ordered and adjudged that:

8 1. Notice of the time and place of hearing has been given as required by law;

9 2. The First Account and Report of Trustee as filed by Gerald M. Hing is approved
10 and settled; and

11 3. All acts and proceedings of Trustee Gerald M. Hing are hereby approved.
