Petitioner, Gerald M. Hing, as trustee of the Oh Thiam Hock/Helen Hing Oh Scholarship Trust Fund B (hereafter the "Trust") hereby presents his Ninth Account and Report of Trustee and alleges as follows:

1. Background. The Trust was created under the will of Helen Hing Oh (hereafter the "Decedent") and funded with \$574,053.17.¹ By order of this Court, Petitioner was confirmed as the sole trustee of the Trust on March 5, 2003. The Trust funds were released to Petitioner on or around August 4, 2003.

2. Period of Account. Petitioner's Ninth Account and Report covers the period January 1, 2013, to December 31, 2013. The supporting schedules to the Summary of Account are attached hereto as **Exhibit "A."** They are incorporated by reference into this petition.

¹ The decedent resided in Singapore at her death and made a bequest of \$1,000,000.00 Singapore dollars to the Trust which converted to \$574,053.17 US dollars at the time of funding.
