17 Petitioner, Jim Hing, as Successor Trustee of the Oh Thiam Hock/Helen Hing Oh
18 Scholarship Trust Fund B (hereinafter the "**Trust**") hereby presents his Twentieth Account and
19 Report of Successor Trustee (the "**Petition**") and alleges as follows:

20 1. Background. The Trust was created under the Will of Helen Hing Oh (hereafter the
21 "**Decedent**") and funded with \$574,053.17.¹ By order of this Court, Gerald M. Hing was
22 confirmed as the sole Trustee of the Trust on March 5, 2003, and the Trust funds were released to
23 him on or around August 4, 2003.

24 2. On December 24, 2017, Gerald M. Hing passed away, and Jim Hing succeeded him
25 as successor Trustee of the Trust pursuant to that certain Order of Instruction dated October 14,
26 2004, a copy of which is attached hereto as Exhibit "A" and incorporated herein by reference.

28 ¹ The decedent resided in Singapore at her death and made a bequest of \$1,000,000.00 Singapore
dollars to the Trust which converted to \$574,053.17 US dollars at the time of funding.

3. Period of Account. Petitioner's Twentieth Account and Report covers the period January 1, 2024, to December 31, 2024. The supporting schedules to the Summary of Account are attached hereto as Exhibit "B" and are incorporated by reference into this Petition. All disbursements were made in good faith, pursuant to the terms of the Trust and in compliance with California law.
