16 Petitioner, Gerald M. Hing, as trustee of the Oh Thiam Hock/ Helen Hing Oh Scholarship
17 Trust Fund B (hereafter the "Trust") hereby presents his Third Account and Report of Trustee and
18 alleges as follows:

19 1. Background. The Trust was created under the will of Helen Hing Oh (hereafter the
20 "Decedent") and funded with \$574,053.17.¹ By order of this Court, Petitioner was confirmed as
21 the sole trustee of the Trust on March 5, 2003. The Trust funds were released to Petitioner on or
22 around August 4, 2003.

23 2. Period of Account. Petitioner's Third Account and Report covers the period
24 January 1, 2007, to December 31, 2007. The supporting schedules to the Summary of Account
25 are attached hereto as **Exhibit "A."** They are incorporated by reference into this petition.

27 ¹ The decedent resided in Singapore at her death and made a bequest of \$1,000,000.00 Singapore
28 dollars to the Trust which converted to \$574,053.17 US dollars at the time of funding.

3. Trustee's Compensation. Petitioner paid himself the amount of \$1,000.00 in reasonable trustee's fees, which represents 0.17% of the Trust estate. The Trust is silent on the issue of trustee compensation and Petitioner has relied upon Probate Code §15681 in determining the reasonableness of his fees. Petitioner has coordinated with the Trust's accountants regarding the timely filing of fiduciary income tax returns and has overseen the investment of the Trust fund and the maintenance of the Trust website. In addition, Petitioner has received and reviewed applications from Trust beneficiaries and exercised his discretion in awarding distributions of Trust funds to applicants in accordance with the Trust's Operating Principals. Petitioner believes that such trustee's fees are reasonable and appropriate for the work undertaken by him as trustee.

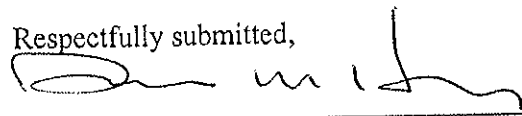
WHEREFORE, Petitioner requests an order of this court that:

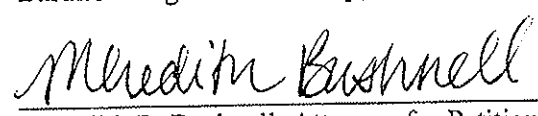

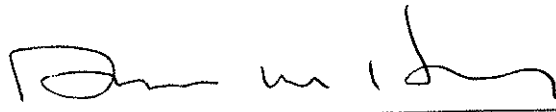
